## 2018 R. V. SITE AGREEMENT

The Great Passion Play, hereinafter “**GPP**” does hereby allow the undersigned, hereinafter “Volunteer”, the space designated as (“Site”) for the placement of a Recreational Vehicle (“RV”), subject to the terms and conditions hereinafter stated:

1. The term of this agreement shall be from \_\_\_\_\_ based upon 15 volunteer work hours a week per individual staying at the RV site. In the event of default due to non performance of the hours required, \$8.50 per hour will be allocated to determine the actual reimbursement due to the **GPP** and \$10 per day site usage.
2. A Volunteer time card will be received upon arrival. Time Cards are due back to the Volunteer Office when you leave (if short term) and by the 10<sup>th</sup> of the following month (if long term). Cards may be filled out online if so desired.
3. RV owner shall maintain the Site and the RV thereon in a clean and uncluttered condition at all times.
4. It is mutually agreed that **GPP** shall not be liable for the safe keeping or the condition of the RV, or any equipment appurtenant thereto, and the R.V. Owner must carry his or her own insurance thereon. **GPP** shall not be liable for any damage or loss to or of the RV, equipment or any property whatsoever, from any cause whatsoever, or for injury to the Owner(s), guest(s) or invitee(s) or any other persons. The R.V. Owner/Volunteer, his or her heirs or assigns, hereby agree to indemnify and hold harmless **GPP** from any and all claims, liability or damages or property or personal injury, loss of life to themselves, family, employees, invitees, guests, agents, or any other persons whatsoever, or property damage or property loss howsoever caused.
5. The R.V. Site Volunteer shall abide by all Rules and Regulations of the **GPP**, including, but not limited to, those rules attached hereto as “EXHIBIT A”. **GPP** reserves the right to amend the Rules and Regulations from time to time, which Volunteer shall abide by.
6. In the event of a breach of this Agreement, or a violation of any of the Rules and Regulations of the **GPP**, including, but not limited to, the specific Rules and Regulations governing the R.V. Sites, **GPP** may terminate this Agreement in person, or upon written notice to the Volunteer at the address stated below, and Volunteer shall promptly pay all sums due **GPP** and remove the rv from the premises. A failure to remove the RV from the premises promptly of the written notice of termination of this Agreement shall constitute an abandonment of the RV. **GPP** shall then have a lien against the RV for any sums owing **GPP**, and may sell or otherwise dispose of the property.
7. **Volunteer here grants GPP a security interest in and GPP shall have a lien against the described RV, including but not limited to the appurtenances and contents, to secure all amounts owed to the GPP under this Agreement or for damage caused or contributed to by the described RV by Volunteer, his guest or invitees, to any property of the GPP or any other person. GPP may exercise any remedy set forth in**

**this Agreement and as otherwise available under the Uniform Commercial Code or applicable law, including taking possession of the RV and the sale of the RV and its contents, without further notice of Volunteer.**

- 8.** The Volunteer shall be required to carry personal injury and property damage liability insurance in an amount sufficient to cover any and all damages caused by the described RV, Volunteer, or Volunteer's guests or invitees. Volunteer shall provide **GPP** with proof of such insurance, a copy of a valid registration for the described RV and a valid mailing address and phone number of Volunteer and shall promptly notify **GPP** of any change in address or phone number.
- 9.** Waiver of any one condition by the **GPP** shall NOT be deemed to be a continuing waiver.
- 10.** All persons causing injury or damage to other persons, property or other R.V.'s or **GPP** property shall be liable therefore, and violations **GPP** rules, disorder, or indecorous conduct by a Volunteer or guest(s) that might injure a person, cause damage to property, or harm the reputation of the **GPP**, is cause for the immediate removal of the RV in question from the premises. Children and pets must be controlled to insure the peace and privacy of other volunteers and guests.
- 11.** Volunteer shall indemnify and hold harmless **GPP** from all costs, losses, or expenses incurred by **GPP** for any damage caused by Volunteer, Volunteer's family member or invitees to the **GPP'S** property and facilities.
- 12.** In the event of a dispute over the terms of this Agreement, the prevailing party shall be entitled to reimbursement of its costs and expenses, including reasonable attorney's fees, with or without litigation.
- 13.** This Agreement shall be deemed to be the complete agreement between the parties. This Agreement may be amended only by written agreement signed by all parties.

## EXHIBIT "A"

### GREAT PASSION PLAY RV SITE RULES AND REGULATIONS

1. All Volunteers must register in the Director of Volunteer's Office upon arriving at the **GPP**. All rules of the **GPP** must be obeyed.
2. Each site will allow one self contained RV and two vehicles. All vehicles must be parked within the boundaries of the R.V. Lot site.
3. Volunteers must register their vehicles at the office upon arrival. Any vehicle on an R.V. site not registered WILL BE TOWED or considered trespassing. ATV's, motorcycles, scooters, golf cars, and other motorized conveyances (except those used in handicap assistance) may be ridden on **GPP** property provided the sound level is kept to a minimum and the vehicle must have headlights and reflectors if used at night. All such units shall be insured with liability insurance and a copy provided to the office before being used on site.
4. A valid driver's license is required for drivers of motorized conveyances.
5. Sewer hose must have a threaded connection on the end when hooking to the sewer pipe.
6. Having pets in the **GPP** property is a privilege. Volunteers must immediately pick up all droppings. Barking or any other behavior that disturbs other volunteers or guests is not allowed and noisy or aggressive pets will not be allowed to stay.
7. Quiet time is from 10:00 PM to 7:00 AM. All radios, music and TV's must be at minimum volume settings.
8. No disorderly conduct, loud music, loud vehicles or offensive language is allowed.
9. Smoking (including e-cigarettes) is not allowed on **GPP** property.
10. Littering is prohibited and garbage is to be placed in the dumpster provided for the RV Sites.
11. Outside clotheslines are prohibited. Please use the laundry facilities.
12. Picnic tables are provided for your use; however, clean up after use is required.
13. Firearms are permitted on the property; however, hunting is not allowed.
14. No trees may be cut without the prior approval of the Director of Volunteers.
15. The RV Site/Facilities of the **GPP** are available for the convenience of the Volunteers and their guests. All persons using these facilities do so at their own risk. The management or owners will not be responsible for accidents, injuries or loss of property by fire, theft, wind, floods or any unforeseen act beyond their control. Violation of any law or ordinance of the county or state will not be tolerated.
