- **We are notified when a show/attraction has a bad experience with one of our employees or volunteers, or when they are asked to make an exception. Please follow the rules, so we will continue to have these benefits in the coming years.**

Must present current pay stub (within the past 30 days) and a valid photo ID.  - Company Policy: for married employee with spouse and dependent children under 18 living at home, OR single employee with 1 guest. Must present check stub issued from the previous 30 days with the name and address of current employer AND photo ID.

 - Company Policy: for employee, spouse and children under 18 living at home, OR employee and one guest. Must present current pay stub (within the past 30 days) and a valid photo ID.

 - Company Policy: Depending on availability, **tickets may be purchased for \$29.99 +tax per person**, 30 minutes prior to pre-show time. Employee must present the box office agent with a paystub issued within the previous thirty days and a valid picture ID. - Company Policy: for employee, spouse and children under 18 living at home. Must present current pay stub (within the past 30 days) and a valid photo ID.
- Privileges include:
 - The Little Opry Theatre—Complimentary admission. Tickets subject to availability 15 minutes prior to show time. Shows include: George Jones-Haggard & Friends, Sons of Britches, The Petersens, Smoke on the Mountain, Rick Ewen Presents the Gambler, The Todd Oliver Show, and Sanders Family Christmas.
 - IMAX Theater – Subject to availability. IMAX Documentary Films are \$7.00 for Adults and \$4.00 for Children (2-12). (Children under 2 are free with paid admission.) Complimentary admission only to “Ozarks: Legacy & Legend”.

- **Pierce Arrow**
 - Company Policy: Complimentary tickets available 15 minutes prior to show time for employee, spouse, and dependent children under the age of 18 living at home, OR individual employee and one guest. Must present current paycheck stub issued within the last 30 days and photo ID. Employee must be present to acquire their tickets.
 - Shows included: Pierce Arrow COUNTRY, and DECADES. No meals. (Excludes our New Year’s Eve Extravaganza and special events.)

 - Company Policy: for employee, spouse and children under 18 living at home, OR single employee and one guest. Must present current pay stub (within the past 30 days) and a valid photo ID.

 - Company Policy: for employee, spouse and children under 18 living at home, OR single employee and one guest. Must present current pay stub (within the past 30 days) and a valid photo ID. Based on availability 1 hour prior to show time. No reservations.

- **Ripley’s Believe It or Not! & Super Fun Park**
 - Company Policy: for employee, spouse and children under 18 living at home, OR single employee and one guest. Must present current pay stub (within the past 30 days) and a valid photo ID.
- **Shepherd of the Hills, Inspiration Tower, Daytime Homestead Admission**
 - Company Policy: for employee, spouse and any children 17 and under living at home, OR employee and 1 guest at no charge. Must present current pay stub (within the past 30 days) and a valid photo ID.
 - All attractions exclude Holidays/Holiday Weekends, sold out dates/tours, and special events. This agreement DOES NOT include the Adventure Park, Christmas events, or Limited Engagement Performances (local rate pricing will apply if available).

2023 Reciprocals for Paid Employees

- **Sight & Sound Theatre: Queen Esther**
 - Company Policy: Admission is extended to either a) employee, spouse, and dependent children under the age of 18 living at home, OR b) individual employee and one guest. The employee and their dependent family or guest must check in together for admission. Must present paystub issued within the previous 3 weeks and photo ID. Tickets may be obtained the day of the performance to be attended. In the event of limited availability, additional time constraints may apply. Tickets are not guaranteed. (I recommend calling ahead to see how close they are to a “sold-out” show, because reservations are not allowed with this reciprocal.)
 - Shows included: Queen Esther
- **Silver Dollar City: NOT VALID FOR VOLUNTEERS**
 - EXCLUDES ALL SATURDAYS, plus excludes 7/4, 9/3, 11/22-11/24, 12/19-12/22
 - Company Policy: for paid employee, spouse, and up to 4 dependents under 18 residing in the household, OR employee and one guest. To obtain tickets, employee must attend with guest(s) and will be required to present a paycheck stub dated within 30 days and photo identification. Those 15 years old and under must be accompanied by an adult 18 or older. (YOU MUST FOLLOW THIS POLICY EXACTLY. DO NOT TRY TO GET IN WITHOUT BOTH YOUR CURRENT CHECK STUB AND ID.)
 - Tickets can be upgraded to a Silver Dollar City Season Pass for only \$65 +tax at time of visit.

- **Talking Rocks Cavern & Cave Country Mini-Golf**
 - Company Policy: for employee, spouse and any children 17 and under living at home, OR employee and 1 guest at no charge. Must present current pay stub (within the past 30 days) and a valid photo ID. Valid for cave tour and/or mini-golf.
- **Titanic – World’s Largest Museum Attraction**
 - Company Policy: for employee, spouse and any dependent children living in the home under age 18, OR employee and one guest. Must present current pay stub (issued within the past 30 days) and a valid photo ID. Based on availability. Excludes the following: holidays/holiday weekends, and sold-out dates/special events.

- **The Track Benefits & Discounts**

- Because we use The Track Brochure Distribution for our brochures, we qualify for their rack benefit program. This is separate from the reciprocal agreement. You must present the “Rack Benefit Card” (only need one per family), your current check stub, AND valid photo ID. Please see the separate Rack Benefit List for the list of discounts.
- PLEASE NOTE: There may be some discounts that aren’t as good of a deal as the regular reciprocal, but there are quite a few new discounts!

- **Turpentine Creek Wildlife Refuge**

- Company Policy: for employee, spouse and any children 17 and under living at home, OR employee and 1 guest at no charge. Must present current pay stub (within the past 30 days) and a valid photo ID.

- **Veterans Memorial Museum**

- Company Policy: for employee, spouse and any children 17 and under living at home, OR employee and 1 guest at no charge. Must present current pay stub (within the past 30 days) and a valid photo ID.

- Company Policy: for employee, spouse and children under 18 living at home, OR employee and one guest. Must present current pay stub (within the past 30 days) and a valid photo ID.
